## **DBE FUN FACT**

What does it mean to provide a Commercially Useful Function (CUF)?

CUF provisions were put in place by the Federal Transit Authority (FTA) to ensure the appropriate claiming of DBE credit. A DBE firm performs a Commercially Useful Function

when it is responsible for execution of the work in its contract and is carrying out its responsibilities by actually performing, managing, and supervising the work involved. Firms must be currently certified as a DBE in the California Unified Certification Program (CUCP) database and carry the appropriate NAICS codes that are affiliated with the work they've been contracted to perform. Other CUF provisions, outlined in the Code of Federal Regulations (CFR), state each firm must perform at least 30% of it's contractual value, buy their own materials and negotiate pricing. If a firm does not pass the CUF review conducted on every DBE subcontractor working on the project, credit will either be reduced or removed depending on the reasoning. #### **CONSTRUCTION UPDATE**

Have you heard about MCTC and the endangered Ridgway's Rail!? This hen-sized bird is a Federally endangered species found principally in California's San Francisco Bay to the southern Baja California region. Due to the US Fish and Wildlife Services naming this bird as Federally endangered, MCTC was made aware of their potential migration through our project along the San Diego River. These birds have the potential to walk along the river in the riparian vegetation as far as 44 miles upstream. Since the



Ridgway's Rail rarely flies and is not known for swimming, accommodations needed to be made to ensure a clear path for walking underneath our temporary trestle bridge and through the active construction area.
