### MCTC STAFF VISIT THE "SHOW ME" STATE

A few members of the MCTC DBE Team traveled to Kansas City, Missouri last week to participate in a very special event. No, the MCTC contingent was not seeking to improve their viewing spot for the August 21, 2017 solar eclipse. While Kansas City was an epicenter for solar eclipse enthusiasts, the purpose of MCTC's travels was to shed light upon the Mid Coast Corridor Transit Project's (MCCTP's) DBE/SB Program by participating in the American Contract Compliance Association's (ACCA's)

National Training Institute (NTI). The annual ACCA NTI is where DBE Program professionals from across the country gather to share best practices on how to increase opportunities for DBE/SB firms on public works projects.

By way of background, the ACCA was established in 1986 as a nonprofit national organization dedicated to ensuring equity and fairness in public/private sector employment and contracting. A key goal of the ACCA is to standardize industry practices in the implementation of Equal Employment Opportunity (EEO) and SB/DBE programs. To this end, the ACCA National Training Institute is held annually to discuss and share standard industry practices with individuals that administer these and related programs. Attendees generally include representatives from public agencies such as SANDAG's Manager of Small Business Development and contractors such as MCTC.

ACCA NTI participants not only learn how to improve the EEO and DBE/SBE programs they implement, they also earn Continuing Education Units from Morgan State University and through time can become certified professionals in the following categories: (1) Certified Compliance Administrator (CCA), (2) Master Compliance Administrator (MCA) and (3) Executive Certified Master Compliance Administrator (ECMCA).

Next year's conference will be held in the Buckeye State...Cleveland, Ohio to be exact. For the reasons stated above, MCTC would recommend that any EEO and DBE/SB program administrator seek to attend. At the very least, you will be able to add a new suffix to your signature line.

#### DBE FUN FACT

Speaking of traveling, are you aware that out of state firms could travel to California to participate as a DBE on Mid Coast Corridor Transit Project? Since MCTC can only claim DBE credit for firms certified as a DBE under the California Unified Certification Program (CUCP), such out of state firms would first need to be certified by the CUCP. Any out of state firm already certified as a DBE in its home state can do this via a streamlined Interstate Application process that will potentially shorten the timeframe to get



certified in California. Conversely, any California based DBE firm seeking to work outside of California as a DBE can get certified in those states using the Interstate Application process. Firms seeking additional information should visit www.CaliforniaUCP.org.

- 4844 Total DBEs in CUCP Database
  - 238 of these are San Diego based firms
  - 593 of these are out of state firms
